



# FAMILY'S FINANCIAL AGREEMENT 2018-2019 School Year

**The school's financial policy states the following:**

The NON-REFUNDABLE tuition deposit is due upon acceptance of a new student or will be due upon submission of the re-enrollment paperwork. The enrollment process is not complete until you have completed the online agreement on the FACTS website. A link to FACTS can be found on the Summit website at: [www.summiteagles.org](http://www.summiteagles.org). The tuition deposit will be refunded **only** in the event that the Administration declines the student's admission. The parents (or legal guardians) agree to enter into a legally binding contract for full payment of the 2018-2019 school year's tuition, regardless of student withdrawal. The assessed tuition is non-transferable. I agree to comply with the guidelines as established by Summit Christian Academy with regard to the payment of financial obligations associated with all school activities, including the non-transfer of transcripts to another institution without full payment of all obligations.

Accounts may be viewed on the FACTS website once enrollment is complete. Statements will not be mailed. Payments are due on the ACH date selected with FACTS. If an ACH payment is returned as "insufficient funds," FACTS will re-run the payment 15 days later. If the payment is returned a second time, a \$75 late fee will be assessed by Summit. It is imperative that monthly payments be kept current in order for the school to meet financial obligations.

**Tuition Insurance**

**Withdrawal**
